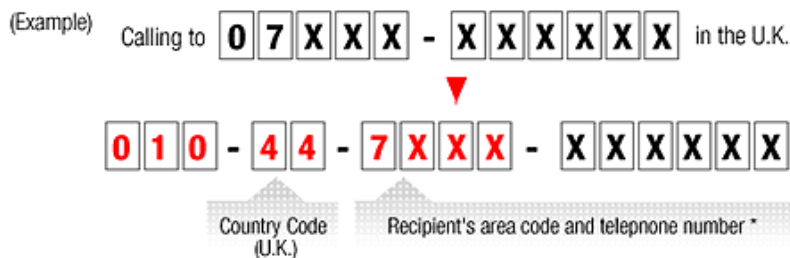

How to make a Voice Call



Omit the initial "0" if the area code begins with "0."

When calling fixed-line phones in Italy or the area code beginning with "0" in Russia, "0" must be included.

Omit the initial "0" if the area code begins with "0."

Will apply when you call to fixed lines or mobile phones of overseas carriers.

When connecting via an operator guidance service in the overseas country, call charges may result even if your call is not connected with the recipient's phone.

Even when making calls to toll-free numbers in the destination country, a call charge still applies.

Various flat-rate and discount services and free communication allowance of your pack plan/packet communication do not apply to this service.

RENTAL AGREEMENT

- * The Owner grants to the Guest the right to use the phone. The Guest should return the phone to the Owner at the expiry of the time of the guest in good working order and condition.
- * The Guest acknowledges that the Guest has inspected the phone prior to signing this agreement and that the phone is in good working order and condition. The Guest acknowledges that the Guest was given an opportunity to reject the phone and obtain another if it was not in good working order and condition.
- * The Guest acknowledges that the phone is the property of the Owner and this agreement does not give the Guest any interest whatsoever in the phone other than the limited right to use the phone for the time on the terms and conditions set out herein.
- * The Guest acknowledges that the Guest has the right to use the phone as bailee for reward only and shall be strictly liable to the Owner for any damage or loss caused to or by the phone for any reason whatsoever.
- * The Guest acknowledges that the phone can operate in the areas or to the extent of the cell phone network to which it is linked or has access.
- * The Guest acknowledges that the Guest is responsible for the payment hereunder during the time, even though any other person used the phone.
- * The Guest acknowledges that the person may not tamper with the security setting on the handset or the Guest will be liable for charges incurred in restoring these setting.
- * In the event that the phone malfunctions and becomes inoperable during the time, the Guest shall forthwith return the phone to the Owner who shall repair or replace the phone for the remainder of the time at the cost of the Owner provided that no such malfunction or damage to the phone was caused by the Guest.
- * If the Guest fails to return either the handset, AC charger or any other accessories supplied to the person at the time of commencement of rental, then the Owner shall bill the Guest for non return of such phone. Please refer to us for these rates by phone.

- * In the event the phone is returned to the Owner damaged, then the Guest shall be responsible for all repair/replacement costs. Please refer to us for rates.
- * The Owner is never involved in the Guest who intends to use the phone to illegal activities or illegal usage.
- * The Guest acknowledges responsible for loss, damage or theft to the handset in whole. The Owner can not cover loss by water damage, i.e rain, any liquid ingression, malicious damage or damage by misuse of the handset or by any unauthorized modification of the phone whilst in the care of the Guest. The Owner does not cover theft from an unattended Motor Vehicle or Premise or theft due to Handset being left in a vehicle.
- * The Guest hereby indemnifies and agrees to keep the Owner indemnified against all costs, losses, damages, claims, actions or causes of action howsoever suffered by or made against the Owner as a direct or indirect result of the use of the phone by the Guest.
- * The Owner shall be entitled to terminate this agreement to the Guest in the event that:
 - the Guest fails to observe or breaches any provision of this agreement or does anything which in any way prejudices the right of the Owner in and to the phone, or
 - disconnect the phone from the mobile telephone network to which it is linked or has access and in such circumstances the guest shall be liable for any reconnection fee which may become payable; and
 - enter into or upon any premises where the phone may be located for the purpose of repossessing the phone and in such circumstances, the Guest indemnifies the Owner against any damage caused (including trespass) while repossessing the phone.
- * The only warranties given by the Owner are those expressly provided herein. Nothing in the agreement shall be taken to excluder or limit such warranties or rights which cannot be so excluded or limited by statute. Where such laws permit the Owner's liability for a breach of any such implied condition of warranty, such liability shall be limited to replacement repair or re-supply only. In all other respects the Owner shall not be liable to the Guest or any other person for any reason whatsoever in respect of the use of the phone. Notwithstanding anything set out herein, the Guest acknowledges and agrees that the Owner shall not be liable for any consequential loss or damage in respect of any cause whatsoever. In no event the liability of the Owner, if any, for damages relating to this agreement shall exceed the actual amount paid by the Guest to the Owner in accordance with this agreement.
- * The Guest acknowledges that the Owner cannot give any warranty or make any statement or representation in regard to whether the phone is adequate for any specific use or purpose. The Guest warrants to the Owner that in relation to any such use or purpose, the Guest has sought and obtained adequate assurances from the manufacture of the phone.
- * The Guest shall not assign its rights or obligations under this agreement or sublet or part with possession of the phone for any reason whatsoever.
- * These conditions including the information on the front of this agreement represent the entire agreement between the Owner and the Guest in connection with the use of the phone. No variation of this agreement and no additional representation or warranties shall be included in this agreement nor shall any right of the Owner under this agreement be waived except in writing signed by a director or secretary of the Owner.
- * This agreement shall be governed by and construed in accordance with the Law of Japan and the parties submit to the non-exclusive jurisdiction of the Tokyo District Court of Japan.
